Introduction

Frimley CCG is fully committed to improving health outcomes in the areas East Berkshire, North East Hampshire and Farnham, and Surrey Heath, totally around 900,000 people.

As one of its priorities is to improve support for GPNs and strengthen the local GPN community in order to provide the best possible service to patients and practices, the CCG wanted to implement a robust, streamlined way of collecting evidence, undertaking appraisals and taking ownership of revalidation.

The key to achieving this objective would be a software solution to manage the process. And that's where we came into the picture.

- Conduct the training roll-out.
- Provide ongoing user support and webinars.

- Demonstrate the easy-to-use mobile version of the Appraisal and Revalidation system.

In just under a year since the successful launch, the project resulted in a fully configured and implemented online solution enabling nurses across Frimley CCG to manage their own portfolios and begin preparing for their Appraisal and Revalidation.

The Premier IT Appraisal and Revalidation for Nurses system has provided a pathway to gather information neatly in a format which is easy to understand and manage in a single toolkit. It continues to be updated on a regular basis with upgraded and/or new additions to the system.
